CONFERENCE SCHEDULE APRIL 13–17

Welcome to the Society of Architectural Historians' 74th Annual International Conference, SAH's second virtual conference!

Our virtual meeting encompasses thirty-six sessions and incorporates many of the events we normally hold at an in-person conference. These include a live Business Meeting and Social Hour (Tuesday, April 13); a live introductory talk by filmmaker François Girard (Wednesday, April 14); and a live Awards Ceremony and a recorded Eduard F. Sekler Keynote Talk by Swati Chattopadhyay (Thursday, April 14). We have organized the sessions across three days rather than two, which results in fewer concurrent sessions. The papers will be pre-recorded and the Q&A will be live. In addition, conference attendees will be able to view 70% of the recorded presentations for 30 days after the conference. The breadth and depth of research that will be presented at our virtual meeting reflects the truly international nature of scholarship on the history of the built environment.

The virtual conference will include a workshop and a seminar on the city of Montreal. On Tuesday, April 13, Ipek Türeli and David Theodore of McGill University will lead a limited-attendance workshop, "Architectural History and the Documentary Film," that will examine the complex intersections of architectural history and documentary film. Participants will look at current techniques for finding and working with documentary film, television, and newsreel footage, and will engage with filmmakers on how filmmaking creates documents for historians.

Cynthia Hammond, professor at Concordia University, has organized the Montreal City Seminar (Saturday, April 17) around the role of conservation as a form of community- or neighborhood-based activism. The seminar will open with Phyllis Lambert, architect, scholar, activist, and founder of the Canadian Centre for Architecture, who will speak on the book she is writing about Montreal. She and Dr. Hammond will have a brief conversation, then a panel of speakers will explore the question of neighborhood-based community organizing, activism, and heritage conservation activities from different perspectives.

We are pleased to have our third Eduard F. Sekler Talk at this year's conference, sponsored by a gift from Mary Patricia May Sekler to honor her late husband, architectural historian and longtime SAH member Eduard F. Sekler (1920–2017). The Sekler Talk brings a notable speaker to the SAH conference each year to address a topic related to the history of architecture, landscapes, urbanism, preservation, the state of the field of architectural history, or a combination thereof. Distinguished architectural historian and SAH Fellow Swati Chattopadhyay will deliver this year's Sekler Talk on the topic of "Architectural History or a Geography of Small Spaces?"

This year we continue to expand our conference and postconference programming for graduate students. Thanks to the generosity of the Gill Family Foundation, 40 graduate students at US institutions were awarded virtual conference registration and a digital membership to SAH. We are grateful to the Foundation for supporting graduate student participation in the conference and other programs for graduate students.

In a collaboration among SAH and the three SAH Affiliate Groups that are concerned with race and architectural history, we created fellowships for ten students of color to become members of SAH for one year, to participate in the 2021 SAH Virtual Conference, and to be paired with mentors who will help them navigate both the conference and the resources that SAH offers throughout the year. Many thanks to the SAH Minority Scholars, Asian American and Diasporic Architectural History, and Race and Architectural History Affiliate Groups for envisioning these fellowships and for working with the SAH Board and staff to fund them.

With generous grant funding from the Andrew W. Mellon Foundation, on March 20 we conducted a pre-conference workshop, the SAH-GAHTC Teacher-to-Teacher Workshop. Organized by Rafico Ruiz (Canadian Centre for Architecture), Jia Yi Gu (Director of the MAK Center, Los Angeles) and Esra Akcan (Cornell University), the workshop was titled "Backstage of the Global Histories Survey: Slow Looking, Translating, Listening, Activating." In a series of presentations and break-out sessions, workshop participants explored processes and qualities that are usually left unattended in the preparation of global surveys and they heard from speakers teaching architectural history in non-Western contexts.

In May 2021, we will offer twelve virtual roundtables and workshops on topics ranging from Community Engagement and Social Justice in Architectural History; Why We Need Public Historians; The Pedagogy of Indigenous Architecture; and Women in Architecture Surveys, among others. These programs will include two organized by the SAH Graduate Student Advisory Committee: a roundtable with the winner of the first SAH David B. Brownlee Dissertation Award and a book discussion with Charles L. Davis II.

The 2021 SAH Virtual Conference has been made possible by the collaborative work of many people. Particular thanks are due to the local co-chairs, Annmarie Adams and Martin Bressani of McGill University, whose enthusiasm and commitment have resulted in a rich program of Montreal-related events. The extraordinary SAH staff deserve many thanks and recognition for their dedicated work in making the virtual conference a reality: Executive Director Pauline Saliga, Director of Programs Christopher Kirbabas, Director of Communications Helena Dean, Comptroller Beth Eifrig, Director of Membership Anne Bird, Communications Intern Miles Travis, and Director of Development Carolyn Garrett.

While we will not meet in Montreal this year, we will have the opportunity to do so in 2023 when SAH will hold its conference at the Hotel Bonaventure. In the interim, we will hold the 2022 conference in Pittsburgh with local co-chairs C. Drew Armstrong and Sahar Hosseini.

I look forward to seeing you at the 2021 virtual conference!
